

# Transport Route Affidavit for transport exemption – Part 1

This is a transport that requires a special route of travel due to length (>30 m), width (>450cm), height (>450 cm) or other reason. You must verify that the transport is able to go along the controlled route of travel. Any obstacles to navigability must be made evident. Indicate also if the route of travel is controlled as regards the transport being conducted after dark.

### **Transport Route Affidavit for transport exemption – Part 2**

### Ground rule

"Road signs, road markings, traffic signals, and other traffic control devices may not be displaced or changed. Anyone who displaces or changes a road sign, road marking, traffic signal, or other traffic control device must immediately restore the device to a satisfactory condition. If this is not possible, he or she must notify the police, or those who set up or maintain the device, of the situation, and take those measures required by the traffic." *Chapter 2, § 9 of the Traffic Ordinance (SFS 1998:1276)* 

#### Measures prior and during the transport

If the transport cannot be carried out without temporarily moving or changing a device, **this shall be done by authorized personnel from the road operator in question**. The road operator must be contacted in good time prior to transport. Any costs for the road operator in connection with this will be paid by the decision holders.
