




### The traffic safety camera system

Is effective:


- Reduces the number of fatalities with about 20–30 %
- Reduces the number of severe injured with about 20 %
- Reduces noise and CO2 emissions
- Has a high acceptance







### Percentage of speeding, at cameras








### High acceptance

- Different information channels





### Responsibility – the Police

- Central unit for investigation
- Investigate and prosecute speeding
- Monitor and control the activation of the camera
- Information to media and the community
- · Set number of photos per year







### Investigation

- Driver responsability
- High requirements of photo (investigative)
- On-line access to databases for comparison of photos with pass port and/or driving license
- Letter to the driver or the owner of the vehicle within ten days

- Location, establishment and maintenance
- Accurate information about speed limits and road signs
- Information to media and community








### Locations
