
# Sveriges bidrag till Marrakesh, 4e ministerkonferensen Februari 2025


The leading cause of accidental occupational deaths

...prevent ill health and accidents at work and create a good work environment...the employer has the ultimate responsibility for the work environment and should lead the work towards a better work environment.



### **ISO 45001**

### Occupational health and safety management systems

Requirements with guidance for use"

- Specifies requirements for an occupational health and safety (OH&S) management system, and gives guidance for its use, to enable organizations to provide safe and healthy workplaces by preventing work-related injury and ill health, as well as by proactively improving its OH&S performance
- 3<sup>rd</sup> most used ISO-standard (app 500 000 companies)

### ISO 45001 - Legal requirements and compliance

#### 6.1.3

Determine legal requirements and other requirements that are applicable to its hazards; determine how these legal requirements and other requirements apply to the organization and take these legal requirements into account when establishing, implementing, maintaining and continually improving its OH&S management system

#### 6.1.4

The organization shall plan actions to address legal requirements and other requirements

#### 9.1.2

The organization shall establish, implement and maintain a process(es) for evaluating compliance with legal requirements and other requirements

#### **Third party**

"An organization is responsible for the occupational health and safety of workers and others who can be affected by its activities. This responsibility includes promoting and protecting their physical and mental health."

#### Occupational health and safety in road safety
